#### **Election Assembly Minutes 2023 (Unapproved)**

The Election Assembly of California Northern Interior Area (CNIA) was held on Saturday, November 10 through Sunday, November 12, 2023.

#### **FRIDAY**

The assembly was called to order by CNIA Chair Claudio at 7pm. The assembly heard announcements and housekeeping items. Introductions: Panel 72 Area Officers and Appointed Chairs were introduced. The Pacific Regional Trustee Reilly was introduced. Those who were attending their first assembly were introduced. DCM Reports:

D9, Christine: I'm the new DCM for Panel 74 - looking forward to serving

D11, Gayle: I've been pursuing groups to get involved in service with GSRs

D15, Lisanne: We have several new GSRs. We also conducted a district inventory. The PI/CPC chair manned a table at the Stand Down event for veterans at the Chico Elks Lodge handing out pamphlets and copies of the recent Grapevine issue focusing on the military. The PI/CPC committee also placed copies of the AA Big Book in the Little Free Library boxes throughout the neighborhoods in the district.

D17, Ryan: We had a lively discussion following a presentation of concept 10. Our district treasurer agreed to prepare a potential spending plan for 2024. We prepared to co-submit a bid to co-host the 2024 Post-conference Assembly.

D19, Steve: The District finances are being reconciled by the interim Treasurer. All Groups that reported were doing good financially. The District inventory was postponed to Panel 74. Webmaster reported that the site design company is ready for input on our wants and Brad has set up a zoom workshop to get everyone's ideas as to what they want on the page,

NCCAA, Ada: conference in San Jose in the spring Norcalaa.org to register. Fall 2024 conference in Sacramento, spring 2025 in Modesto. Jan 27 is the next committee meeting

Foro, Luis: event will be in Tulare December 3

Young Peoples in AA: Davis YP meets Friday nights at 7 Hispanic Women's Conference, Herminia: The date of the workshop will be on December 9, 2023, in Pasadena, CA. It will be a Hybrid event, English interpretation available. The Area contribution was deposited. The Committee meets on the 1 st and 3 rd Sunday of the month via zoom. This year I will bid for Area 07 to host the workshop in 2025. Area 06 will be hosting in 2024. Appointed Chair Reports:

Accents, Jeff: We need to change printers, I'm working on getting bids

Archives, Nancy: Herminia and I participated in the District 54 Service Meeting. We took the Archives display to the District 54 Anniversary. e-Services instructed me on Google Workplace and helped to transfer all the files from my personal computer to the Archives computer. I attended the Pacific Region Archives Committee. Our Archives Committee met to discuss creating a non-rotating archivist position, and relocation from our current unsafe, upstairs, non-wheelchair accessible repository building with no Internet to a safe, accessible location with Internet. We've looked at several places so far, but nothing ideal. Open to suggestions

Alt Archives, Herminia: I attended National Archives 2023, I attended several panels: (Where Do I begin? Standards, Guidelines, Deed of Gift), (Preservation Basics, Conservation Funding), (Traveling Displays, permanent exhibits). Honestly, so much to learn and it can't be done just by attending 2 Archives workshops. I learned we have The Archivist's Serenity Prayer – Grant me the Serenity to accept the collections I cannot decline, Courage to decline the collection I can, and The funding to process the backlog. Bridging the Gap (BTG), I want to ask you to consider the opportunity to be of service as a volunteer for BTG. The basic requirements are 6 months of sobriety and a working understanding of the 12 steps and 12 Traditions and a familiarity with the meetings in your district. If your DCM asks for volunteers, raise your hand. You are agreeing to meet a newcomer at their first meeting on the outside, introduce yourself and introduce them to other AA members with experience; give them meeting schedule, point out the different types of meeting. Get them started on a phone list and encourage them to find a sponsor and a home group Arrange to show them a few more meetings. That is it.

Eservices, Jessica: I have continued to schedule introductions to the Google Drive for Pass It On's for Area Officers and Appointed Chairs. We had a special guest join us our last eservices meeting - Area 11, Ted P. from Connecticut. He is in charge of the exploration of creating a Technology Committee for their Area. We've been researching online options for online Assembly registration that will be managed at the Area level in cooper-

ation with host Districts - we'll pilot Tito at the winter assembly. We have also worked to set up an Area PayPal account to help manage subscriptions to ease automatic payments as the next panel rotates in.

Finance Committee, Don: We learned a lot this panel and want to share with the next committee ome of the challenges we faced – trying to get the conscience from the area, making sure we were spending the area's money the way the groups would want, as well as trying to balance best business practices with our primary purpose (e.g. sending all chairs to PRAASA?)

Grapevine, Jorge: I want to thank all the different districts that invited me to their unity days. Take advantage of the discounts that Grapevine has on subscriptions for holidays and the new book in Spanish of oración y meditación from la vina Literature, Beth: Literature is all stocked up. Some back orders came in.

Oral Translation, Jose: I translate all the Reports at the ACM's and Assemblies, I love my Service and attend as many events as possible. I make sure the interpretation equipment is working properly. I'm willing to help the next special worker and offer my knowledge at any time it is needed.

Written Translation, Amanda: Working on a pass-it-on. This has been one of the best experiences of my recovery SATURDAY

The assembly was called to order at 9am. The assembly heard housekeeping items and opening readings.

Introductions: CNIA 07 delegates (Bob P36, Vikki P66, Mike P68, Tom P70), past delegate Kunane from Hawaii, as well as members from CNCA 06 were introduced. A district roll call was conducted.

Past delegate Tom gave an overview of the weekend.

Consideration of 2023 Post Conference Assembly minutes: Lisanne stated that on lines 2-3 it says post conf assembly was may 5 and 6, it should be May 6 and 7. Margie motioned to approve the minutes with this correction. It was seconded by Carlos and approved by substantial unanimity.

Assembly Reports:

Post Conference 2023, Lisanne (D15): 152 total registrants, 110 paid for dinner. Cost was \$2205 for the facility. \$4497 total income, total expenses \$5959

Winter Assembly 2024, Luis (D53): we have a location, working on getting online registrants

Pre Conference 2024, Mike (D36/34): We have a venue in Denair, working on hotels

Post Conference 2024, Ramon (D55): we're excited and nervous to host, we have 4 volunteers so far. Working on a facility Mini PRAASA, Titia (D30/33): hosted at FrogTown in the main building, we have a chairperson. D33 will be running snack bar and concessions

The seventh tradition was conducted.

Old Business:

Create Funded A/V Tech. Carrie rescinds the motion from the last assembly to submit this motion. Motion to create a fully fund-

ed A/V Technician to serve on the Area 07 Standing Technology Committee. Motion was seconded by Lisette.

Historically, all Area equipment has been stored and managed by the Alternate Chair at their residence. The Area's equipment needs continue to grow with the introduction of Hybrid ACMs in Panel 72. The Alternate Chair should have the opportunity to focus on other needs of the Host Committee at assemblies instead of managing the PA system and other equipment. The tech chair needs to be free to focus on running the hybrid ACMs and not managing equipment at the same time.

Proposed duties for the Equipment Manager:

Store all Area audio, visual, translation, and hybrid technology equipment

Run sound system at Area assemblies, working with the host committee and alternate chair

Run sound system and hybrid audio/visual system at ACMs working with the technology chair

Proposed AV technician spending plan 2024

Mileage \$1000, lodging \$1200, registration/meals/coffee \$120 (total \$2320)

Discussion

Is assisted listening included? Yes

Will there be a change to the Alt Chair's expenses? No. The only change would be if this position was the one to take equipment to events that the Alt Chair does now (mileage)

Our proposed spending plan is 15k in the red so it's hard for me to add additional expenses

My concern is storing at someone's house (someone clarified that the equipment is insured)

I'm very supportive of this to keep hybrid working well

I've served as eservices and alternate chair. Eservices looks a lot different today and is a lot on top of being a DCM. i'm in favor of this motion

Will this position be sent to PRAASA? No

Who will appoint this position? The area chair

To be clear we already have hybrid equipment

Motion passes

Archives Chairperson. Motion to make the following amendment to the CNIA Service Material Book from G. Be available to attend the National Archives Workshop (Alternate Archives Chair) to G. Chair be available to attend the National Archives Workshop (Archives Chair and Alternate Archives).

Discussion

The workshop has two sessions going on at the same time, so it's important that both the Archivist and Alternate Archives chair can attend

I served as Archives for 6 years. I think we should fund both Our spending plan is about 10% allocated to Archives, not taking into account the new location we may move. It's a bit disproportionate spending, and I would not support this

As alternate, there's so much to learn I don't feel like it can be done in just two years

I'm not in favor of this because when we first voted to have an alt position, the current archives chair said it wasn't important for them to be funded to the workshops because they'd attended the previous ones. I think we should also be mindful that we can't attend everything - for example when I attend PRAASA I can't go to every round table, I have to pick and choose

I think we should fund the archivist for year 1 and alt for year 2 43 in favor, 61 opposed. Minority opinion - we need someone trained to handle these important materials; there's 43k in our reserve for no stated purpose right now; I can't fathom how much information there is to learn. Valarie made a motion to reconsider, it was seconded by Cathy. The motion to reconsider passed by simple majority.

Discussion:

It was great to get to hear both of them share the different panels they went to

I see the workshop as an investment in our trusted servants and that they'll bring this information with them not just to the area but also to their home groups, etc.

Though the percentage of archives spend is high, it's not as high as it is in other areas

If the service need is there we should take care of it, not be concerned about money

I've seen our spending plan anticipate a loss of 20k and we've instead made 7k. While we may not be able to do this forever, we currently have the resources to send both

61 in favor, 19 opposed. Motion passes.

**New Business:** 

Combining Accents and Recording Secretary. It is hereby moved to combine the responsibilities of the Area Secretary position with the Accents Appointed Chair Position. This would remove the budget allotments for the Accents Appointed Chair from the 2024 Proposed Spending Plan.

History: As technology has advanced and our need to mail printed copies of the Accents has drastically diminished, the opportunity to combine the two positions was discussed as a way to reduce the annual spending plan and be more efficient with our service positions. It is an opportunity to evaluate the timing of the Accents, as well as the format and ensure efficiencies at each level of production. The current secretary is confident that this is a reasonable merging of duties.

Proposed recording secretary job description:

A. To take minutes and maintain approved minutes of all business at Area Committee

Meetings and Area Assemblies.

B. To have available at each Area Committee Meeting and each Area Assembly a complete

file of all approved minutes of Area business of the current and immediate past panel.

C. To assist with Area correspondence when requested by the Area Committee.

D. To record and maintain audio recordings of Area business until relevant minutes have

been approved.

- E. To maintain and distribute the Area Accents/Acentos as follows:
- a. To keep the Area Accents/Acentos within the framework of its stated purpose: to keep the Area informed of all motions and/or recommendations made and all actions taken by the Area Committee and Area Assemblies.
- b. To coordinate with the Area Treasurer for funding of printing and mailing cost.
- c. To publish the Area Accents/Acentos in a readable fashion including design and layout.
- d. Coordinate with the Written Translation Chair for the Acentos.
- e. Coordinate with the Registrar to update the Accents/Acentos postal and email lists.
- f. Submit Accents/Acentos to Area Chair for approval prior to distribution.
- g. Keep informed of Finance Committee's budget preparation schedule. Provide adequate space and timely publication of the proposed annual Spending Plan, and minutes covering the discussion of the Spending Plan.
- h. Email the Accents/Acentos.

#### Discussion:

This makes sense logically, the only thing secretary does is take minutes that go in the Accents the context may be helpful to write the newsletter

Area 18 in Idaho has a combined position

When I was Accents it was a big job, not sure if it's been streamlined since then

Finance committee supports this

Do we have a plan on training? Yes

Is there a new program for Accents publishing?

Motion passes. Minority opinion - this would take away another position that allows another person to be a part of the area; why would we make this decision today when we have elections today. Tina makes a motion to reconsider, Margie seconds the motion. Motion to reconsider does not pass. Motion stands Retire Oral Translation Chair. Don made a motion to make the following amendment to the California Northern Interior Area (CNIA) Service Material Book, section on Committees and Trusted Servants, Page 10 of 13 from existing Oral or Verbal Translation Chair to no chair...to retire the position Oral or Verbal Translation Chair (as the service is carried out by Area-approved paid special workers for long-term sustainability). Sam seconds the motion

Area 7 has had oral or verbal and written translation chairs. This panel and last, it was realized that the oral translation chair had a substantial burden of translating area committee meetings, assemblies and other events. It inadvertently fell on one person, typically, and the workload is too much and may interfere with experiencing the meeting and serving in other ways. A model similar to that of professional interpreter was suggested and later approved by the Area. Funding in the spending plan was also

approved. The roles of Oral Translation Chair role and paid special worker are redundant.

#### Discussion

I think there's more to the oral translation chair than just interpreting, I think it would be a disservice to our area to remove this chair (especially their attendance at PRAASA)

I think we've outgrown the position; by hiring interpreters we're improving our commitment to make sure everyone is able to participate fully

Who would be responsible for funding this position? The chair. I think we should keep this position and the oral translation chair should coordinate

We invite our GSRs but they're afraid because of the language barriers

We should keep the position because the chair is someone that's been able to unite us, not just translate at meetings. Removing this position would separate us

I've observed the chair doing more than just interpret, we should keep this position and reassess in one year

We need the coordinator to make sure the translation is correct The oral translation chair collects and translates the reports. If not this position, who will be the link in the chain for linguistic districts to go to PRAASA?

I don't think the title oral translation chair fits what this person is doing anymore

Motion does not pass unanimously

Archives Rent: Don motioned, It is hereby moved to incorporate an increase Line 189 of the current proposed California Northern Interior Area (CNIA) Spending Plan - the Archives facility rental cost – in order to relocate Archives to an accessible location: from \$235/mo and \$2,820/yr to approximately \$1,000/mo or \$12,000/yr That is an approximate difference of \$9,180. Titia seconded

From time to time, we have to adjust rent and other expenses to serve alcoholics and our Area functions. The Archives location is quite affordable, but lacks Wi-Fi and is not in a setting that is safe at all times and conducive to the service – for trusted servants and the many members who would like to visit for an event, experience the archives and contribute to their upkeep. Current rent is \$235/mo or \$2,820/yr. In looking for a more appropriate location, we anticipate to approximately \$1,000/mo or \$12,000/yr – a difference of \$9,180. This is an example of why we don't just spend down excess funds and have a prudent reserve (PR); we will not need to use the PR

This motion will be discussed at the winter assembly Presentation of 2024 Spending Plan. Holly - we adjusted our proposed contributions because we are on track to receive more than our three year average anticipated. Income from literature and GV sales on lines 14/15 now match the expenses on lines 183/184. Assembly income line 16 now matches line 170. Added \$500 for delegate expenses at conference line 170, 500 for delegate to participate at NCCAA line 29, 500 a year for delegate to attend international every 5 years, reinstated PRAASA for all

appointed chairs, increased Spanish translation at ACMs to what we are paying line 155, changed name of our Online Transactions Fees (formerly Web Processing Fees line 216) The body discussed and the finance committee fielded Q&A 76 in favor, 2 opposed. There was no minority opinion. Spending plan passes.

Panel 74 Elections: Matthew L (Delegate), Claudio B (Alternate Delegate), Holly J (Chair), Emily L (Alternate Chair), Don H (Treasurer), Jose U (Recording Secretary), Jessica J (Registrar) Pacific Regional Chair Report, Reilly: Reilly explained her duties as pacific regional trustee. She discussed agenda topics, and asked that groups spend time discussing what to do with the founder's words in our literature. I am the chair of the archives committee and we recently discussed a three phase project that will be brought to the conference (phase one will be a progress report including the cost to house, preserve, and care for our archives). I'm on the nominating committee, and the AAWS finance and auditing committees. The Young People in AA pamphlet was revised and is available. Don't forget the only way Grapevine can get contributions is by Grapevine subscriptions you can get it through the Grapevine app.

Delegate Report, Jenn: There are over 16K downloads of the Grapevine app, it's \$3 / month for the current version and digital versions - you may have noticed there are glitches that are being worked on. All delegates have had an opportunity to read the first 6 chapters of the plain language big book. AA for the Black and African American pamphlet will be named Black in AA: Experience Strength and Hope. AA for the Native North American pamphlet will be having a call for stories. Work is continuing on 4th edition Alcoholicos Anonimos and the 5th edition big book (they're still reviewing 5th edition stories). Do You Think You're Different? pamphlet is having a call for stories through April 30. Background information for agenda topics will be available by the Recording Secretary, Panel 72 end of February.

There was an ice cream social while Reilly shared her recovery story.

SUNDAY

The assembly committee reported 211 registrants for the weekend. Business was resumed (notes above)

Officer Reports:

Registrar, Loren: All registration requests and inquiries have been processed and responded to. I participated in the CNIA portion of District 54's Anniversary meetings. I'm also the parking chair for this Election Assembly and participated in the Host Districts planning meetings. District group & service reports are on our Area Google Workspace. If you don't currently know if you are registered with GSO see me


#### **GSR Preamble**


