## Area Chair Report

There is a lot going on in Area 07 as we approach the end of the year, and we have a lot of information available to review and discuss with your groups posted on our website at cnia.org

Our Fall Assembly, hosted by District 30 in Angel's Camp, had 149 registered attendees, though participation was lower on Friday (65) and Sunday (86). District 33 provided dinner on Saturday, and we tested a hybrid option with some online participants to prepare for future assemblies.

**Area business** that occurred at our Fall Assembly should be communicated to your groups. Some of these discussions will resume at our Winter Assembly in January.

- The Proposed 2025 CNIA Spending Plan was presented, discussed, and approved with substantial unanimity. The vote was 71-11 in favor to approve, and after hearing minority opinion, there was a motion to reconsider and a second. The vote to reconsider failed 30-43, so the original vote stands to approve our 2025 Spending Plan.
- We elected our CNIA past delegate, Tom A., as our candidate for the Pacific Region to consider nominating as a Trustee-at-Large U.S. to the General Service Board.
- We discussed hybrid assemblies and accessibilities under Old Business, and Curtis, Alt-DCM (D22), made a motion that Christine, DCM (D09) seconded. The motion reads as follows:

**MOTION:** It is hereby moved to amend the CNIA-07 committee structure to add a funded appointed chair position for an Accessibilities committee with a budgeted amount of \$2,900 a year.

This motion was tabled and will be discussed at our Winter Assembly in January. The motion and background material are available on our website for review with your groups. Please be prepared to discuss and possibly vote on this matter in January.

• We held our Area Inventory on Sunday with small group discussions. Thank you to Area 6 for joining us to help support and facilitate our Area Inventory. Our Alternate Chair, Emily, will compile the inventory responses and share them with our committee so we can generate an action plan to prioritize and address concerns in our area.

As per the assembly action approved at our Post-Conference Assembly in May to relocate our Area Archives, the area officers unanimously approved a new location at Florin Square in Sacramento. The unit is not available yet, but we hope to move in soon and celebrate our relocation.

Our Area Planning Meeting is next month on December 14th. If your district would like to host an assembly, please be prepared to submit a bid at this meeting. Assembly information and bid forms are available in our CNIA Service Material Handbook and on our website at CNIA.org.




Members wanted to explore alternative options to an expensive office space used only twice a month. They appreciated the cautious approach to finding the right location without rushing into an unsustainable situation.
