Chair report

We've had a couple of assemblies since our last Area Committee Meeting (ACM) in March; so this Accents includes minutes from the March ACM, and we will be following up on business from that meeting at our ACM this month. The following motion will be discussed under old business (*See pg. 7 under New Business – Spending Plan Discussion – for background information on this motion*):

MOTION: I move that Area-07 wait 45 days between the presentation of the proposed [spending plan at the ACM] and the initial vote of the Area on that [Spending Plan].

Our Post-Conference Assembly in Nevada City did not disappoint! We had 181 people registered for this event, with healthy attendance both in the room and online. We did have a couple of technical hiccups, but we paused so as not to alienate our members attending online.

- We heard our delegate report back on his experience at the General Service Conference
- We heard a couple of really good, informative panels regarding leadership, participation, and service.
- Old business included a vote on a motion made at our Winter Assembly in January requesting that our area forward the *proposed Twelve-Step Checklist* to the General Service Office as a proposed agenda item (the motion did not pass).
- New business addressed our Area Assembly Structure, and we heard a lot of really great comments and ideas of how we might consider changing our assembly structure moving forward (We collected survey responses that provided some helpful feedback, as well). More to come, as we will continue this discussion in the coming months.
- We also had a mock voting session to test a digital voting platform that we plan to use to simplify the voting process and save time at our fall assembly when we have elections for the next panel's area officers and vote on our 2026 spending plan.

Looking ahead, your elected officers and appointed chairs are outlining their *experience, strength, and hope* with their service positions, and their service experience will be available for you to review before elections in November. We hope you will consider making yourself available for general service in our area! (Position duties area available in the SMHB.)

Our Election Assembly will be coming up November 14-16 in Tracy (D37). This is a 3-day assembly that starts on Friday evening and goes thru Sunday afternoon. Registration information will be available soon, but you can [start planning for this weekend's event now!](#)

Conferences are held for one purpose--to carry the message. Bill W was the main speaker at the 1st NCCAA conference. Two conferences are held a year: Spring 2025 Modesto, March 7, 8, and 9, 2025 (DoubleTree by Hilton). There were 618 registrations. The conference was a success. NCCAA. Treasurer election held. Jason S. was re-elected as. Treasurer. The Treasurer election is held every 2 years in odd years. Fall 2025 – No Conference due to the International World AA Conference. Spring 2026 – San Ramon March 20, 21, and 22, 2026 (San Ramon Marriott). Registration is available online at norcalaa.org, or Lorraine may have placed flyers on the table. Delegate Report, Matthew L: Posted to website on Delegate's Page

Sharing Session: What's on your Mind & PRAASA Experiences

Several DCMs, Officers, and Appointed Chairs attended PRAASA in Area 02 (Anchorage, AK) and provided reports about their experience. We heard as many as 12 reports and the general consensus is that attending PRAASA is a valuable experience that inspires and grows our future service leaders. However, there is some expressed concern of the cost to our area to fund all officers and appointed chairs to this regional service assembly.

New Business – Spending Plan Discussion

Background: Our 2025 Spending Plan was presented at the 2024 fall assembly, and it was approved with substantial unanimity. We heard minority opinion, and after a motion and second to reconsider vote failed, the original vote stood to approve the 2025 Spending Plan.

Area Chair receive an email from a district in early March expressing concerns regarding the timeline and process for our Area Spending Plan preparation, presentation, and approval. Our current spending plan timeline is outlined in our Service Material Handbook (SMHB), which identifies our September ACM for final review of a proposed spending plan to present for a vote/approval at the fall assembly.

Our fall assembly currently toggles between October (even years) and November (odd years), leaving a very short turn-around time in even years before we present the proposed spending plan at our fall assembly in October (*October Accents distributed October 6th and the Assembly began on October 11th*). The concern is that there is not sufficient time for GSRs in our area to review and discuss the proposed spending plan with their groups, so they can have an informed opinion to share and vote on the proposed spending plan at the fall assembly in October. Furthermore, *The proposed spending plan presented at the ACM prior to our Fall Assembly in 2024 was materially different than the proposed spending plan that was presented and put to vote at the Fall Assembly (Added to amend/approve minutes at June ACM).*

After thoughtful discussion and consideration, Greg N. (D30) made a motion that was seconded by Eric K. (D20). The following motion was tabled to continue discussion at our next Area Committee Meeting (ACM) in June (*after Pre -& Post- Conference Assemblies in April/May*).

MOTION: I move that Area-07 wait 45 days between the presentation of the proposed [spending plan at the ACM] and the initial vote of the Area on that [Spending Plan].

Officer Reports:

Registrar Debbie S: It's been a very busy start to the 2nd half of Panel 74 for your new Registrar. I executed and distributed the group and service position reports, and subsequently processed dozens of change requests from our districts and groups. Some new groups were added, and a few inactive ones were closed. Several open DCM, GSR and their corresponding alternate positions were filled by excited new servant hearts. A couple of groups changed their name and a few others merged with fellowships. When I didn't have the proper authority to make some of these database updates myself, the GSO member services team took care of them for me quickly. I was invited to District 47's virtual GSR school, as well as a conference agenda items workshop in Sacramento sharing on 2 important pamphlets. With support from our webmaster Carrie, I updated our group number look-up page on the CNIA website so that all groups are available for search and display regardless of their status. And finally, I attended the 2025 PRAASA in Anchorage Alaska last weekend. That report will come at a later date.

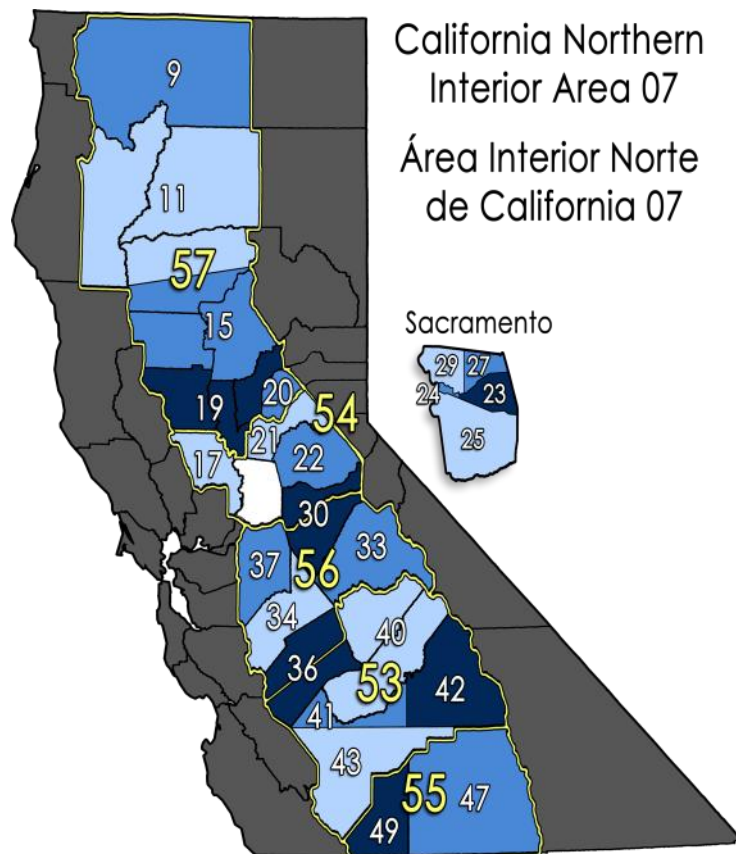
