Chair Report

Greetings faithful and trusted servants! We are heading into the final stretch of this panel, and I encourage everyone to remain steadfast and focused as we forge ahead for the remainder of this year – continuing to make progress toward whatever comes next for our area, your districts, and all of our groups and members.

Our August ACM had lighter than usual attendance with just 34 people (24-26 in person and 8-10 online). We successfully tested our Spanish interpretation remotely (from the next room), so this should be a good cost savings for our ACMs going forward – paying for the service but not the mileage reimbursement.

- An Assembly Structure Ad hoc Committee has considered comments from ongoing discussions regarding possible changes to our assembly structure. The committee will offer a recommendation and a draft proposed motion at our September ACM. Any proposed changes to our assembly structure will be brought to an area assembly for consideration by the body. We will distribute a draft proposed motion to districts and GSRs, so they can inform their group, get feedback, and be prepared to discuss and possibly vote on a motion at our 2025 Election Assembly. If approved, changes would affect our 2027 assemblies (determined at our December 2025 Planning Meeting).
- Our Treasurer and Finance Committee Chair held three Spending Plan Workshops over the past few weeks to get feedback helping to inform our developing Proposed 2026 Spending Plan. The final Proposed 2026 Spending Plan will be made available for GSRs to review and discuss with their groups prior to the Election Assembly in November, so they can be informed by their groups and participate in the discussion and possibly vote on our 2026 Spending Plan.
- We had our 2nd *Lean into Service* workshop in District 11 (Redding) last month. Our final *Lean into Service* workshop will be a hybrid event hosted by District 37 on October 25th. *The purpose of these workshops is highlight various opportunities and paths to service in our area, motivate others to get involved with general service, and to cultivate future service leaders in our area. Our **Election Assembly** will be hosted by District 37 in Tracy on November 14-16. This is a 3-day assembly that starts on Friday evening and goes thru Sunday afternoon. Registration is available on our website, and you can <u>start planning for this weekend event now!</u> We will be electing our Area Officers for Panel 76 (2026-2027) and presenting our 2026 Proposed Spending Plan for consideration.



Archives Presentation

History is never a completely accurate representation of what has occurred in the past. It relies on the interpretation of available data, and even the most thorough historical records struggle to reconstruct events accurately. standing of Alcoholics Anonymous (A.A.) history is often little more than a collection of facts and interpretations from individuals who witnessed those events. The information presented below consists of recollections from people involved in that history, preserved in writing over the years since the founding of Alcoholics Anonymous.
