# Chair Report

We must be having an amazing time, because time is flying by as we near the end of Panel 74. Many groups and districts have already elected their trusted servants for the next panel to serve in 2026-2027 (Panel 76). I would like to congratulate you all and welcome you to your general service journey. We look forward to your inauguration in January!

We had 43 people attend our September Area Committee Meeting (ACM), with 28 people in the room and 15 people attending online; and our Spanish interpretation is now successfully being provided remotely, thanks to the collaboration of our tech team – well done!

- We have been discussing our proposed 2026 Spending Plan over the past few months, and our treasurer distributed the final version last month. General Service Representatives (GSRs) are encouraged to review and discuss the proposed spending plan with their groups, get an informed group conscience, and be prepared to discuss and vote on the spending plan at our fall assembly. The proposed 2026 Spending Plan and related material are available for review on our website at <a href="mailto:cnia.org">cnia.org</a>.
- The Assembly Structure Ad hoc Committee has revised its recommendation in favor of fewer changes to our assembly schedule. We are now proposing four 2-day assemblies and one day online assembly in the summer. This would reduce our fall assembly by one day and provide an additional day to address area business in the 5-6 months between our Post-Conference and Fall Assemblies. Hybrid option available
- Our Accessibilities Chair has been working diligently to compile resources for members and groups and has launched a new newsletter <u>Access 360</u> that features shared experience and personal stories. The October issue of Access 360 features a story written by one of your peers a member of the "blind type." Ron writes, "No person does anything without help somewhere, sometime, and in some way. The more we can make service in A.A. accessible, regardless of disability, the more we will feel like we are fully a part of Alcoholics Anonymous."
- Lean into Service at our final service workshop on October 25<sup>th</sup> in District 37 (Stockton). The purpose of these workshops is to highlight various opportunities and paths to service in our area, motivate others to get involved with general service, and cultivate future service leaders in our area.
- Call for Resumes! If you are eligible and making yourself available for an area officer position
  or the area's nominee for Pacific Regional Trustee at our Election Assembly, resumes are due
  to the Chair by 10:00 am on Saturday, November 15<sup>th</sup> (please provide at least 2 copies).

Register now for the CNIA **Election Assembly** on November 14-16 in Tracy, hosted by District 37. This 3-day assembly starts on Friday evening and goes through Sunday afternoon. We will be electing our Area Officers for Panel 76 (2026-2027), presenting our 2026 Proposed Spending Plan for consideration, and electing a nominee for Pacific Regional Trustee.

The **Area Planning Meeting** on December 20<sup>th</sup> will be a potluck, so bring your appetite and your favorite dish to share! Districts interested in hosting an assembly in 2027 should be prepared to submit an assembly bid at this meeting. <u>Assembly Guidelines and Bid Forms</u> are available in our Service Material Handbook and on our website.



Hispanic Women's Conference- Patricia G: I regret to announce that I will be stepping down as chair for the 2025 Hispanic Women's Workshop. I initially believed my role as Liaison was solely to support, not to lead the committee and plan the

workshop. After the 2024 event, I hosted planning meetings every Sunday, but due to a lack of support and participation from others, I remained the only committee member.

I want to emphasize that the Hispanic Women's Workshop is still happening, but Area 07 will no longer be hosting it. I have asked our Delegate, Matthew, to inform the other Delegates of this situation. Thank you!

The 24th Anniversary will be Sunday, December 14, 2025, in Chowchilla. This year, the host is District 53. Linguistics Districts 53, 54, 55, 56, and 57 continue to participate in this amazing event. Area 7 continues to support us. On Sept. 21, the Foro Committee will be meeting in Los Banos, which I will be attending. Looking forward to attending this fabulous event. I invite the fellowship to come and celebrate with us. Live and Service.

#### **Central Offices/Intergroups**

Central Valley Intergroup, Beth S: Happy 24 hours. We just had our old-timers panel last weekend, and it went well. Our next event will be the holiday extravaganza on December 13th. I will provide fliers when they are available. All our events are on the CVI website at cviaa.org. Thank you for allowing me to be of service

H & I. Vikki L: Two or more members bring an AA meeting into hospitals, recovery centers, rehabs, community facilities, jails, and prisons in Northern CA. AA Literature is brought into the meetings and provided free to the members who attend. This is where approximately 90% of the money contributed to the H&I Pink Cans goes. There are a few ways to volunteer: in your local area or at a prison. Provide Sponsorship. At selected and authorized prisons, we provide inside Visiting Sponsorship Services. We match prisoners requesting sponsorship with specially oriented anonymity-protected volunteers.

NCCAA Interior Secretary, Sue B:\_NCCAA stands for Northern California Council of Alcoholics Anonymous. In 2024. NCCAA celebrated its 75th Anniversary. NCCAA was started because of an idea, from Bill W. in 1946, to create and test the representation of groups via delegates to communicate with AA headquarters in New York. Bill worked with Nic N, San Francisco, to organize and test this idea. The first NCCAA Conference was held in 1947, and Bill W. was the keynote speaker. The idea for group representation for AA has evolved into our General Service structure. Thank you for allowing me to be of service, Sue B.

Spending Plan Presentation Treasurer Don H: 2026 Spending Plan Version 3: Changes or Additions Generally speaking, the following seems apparent – we are currently at –\$767.68.

- 1. Since last month, we reduced the cost of mileage in two ways: -From chairs, as it was included. ACMs, which are not technically required, saved a little under \$3,000. -Interpreter mileage to. ACMs; that costs about \$450 less
- 2. There is some support for raising contributions to \$68,000; definitely for raising it up from \$64,000. There is some support for \$66,000 instead. -We left it at \$68,000, though \$66,000 would be more incremental and may be more prudent.
- 3. It is mixed in terms of support for 8 PRAASA and 4 special conferences this year only. -Some suggest more going; no one suggests less, though some would like less than \$15,200 spent. This is how many learn their role and is a key part of training. -We left it at 8 and 4 going.
- 4. There is not very good support for reducing mileage to 0.50/mi based on principles and experience. -We moved it back to 0.70/mi. We put a survey question in to see if there is good support for 0.60/mi.
- 5. There appears to be good support for moving 2 ACMs to virtual. -We kept that in the calculations (savings of \$3,500).
- 6. We are collecting information on whether it is okay to plan to overspend \$5,000 or \$10,000 (or 5% or 10%) of the spending plan, since we typically do not spend it all. -More to come...input in process, but \$5,000 is supported by many so far.
- 7. We kept the increased GSC workshop and unreimbursed other district mileage (codes 8071/2) at \$1,200 and \$1,200.
- 8. Other suggestions... -We did not change it, but some suggest we raise the GSC contribution from \$3,600 to \$5,000 to be more self-supporting; it actually costs about \$10,000. -Rent for ACMs and storage is being re-evaluated; if it works out, that may save \$500-\$1,500. -Since the Pacific Forum is in San Diego, costs will be less, and maybe consider sending another person? BTG Presentation Bridging Rachel A: Good afternoon, and thank you for allowing me to serve CNIA Area 07. My name is Rachel, an alcoholic, and your Area Bridging the Gap Appointed Chair. I attended the Bridging the Gap Workshop Weekend for the second year in Ontario, CA, hosted by Area 05, along with five other representatives from CNIA 07. The hybrid workshop had great online participation, and recordings will be shared soon. I reconnected with workshop chair Mark S. and assisted with various tasks. Diana A. from San Diego shared her 23 years of BTG service experience, emphasizing the committee's perseverance. I helped grab donuts for the morning meeting, starting the day on a positive note. The Professionals Panel included Mike M. discussing The Other Bar program and representatives from Pasadena Impact, who highlighted H&I efforts. They noted the importance of incorporating Bridging the Gap into recovery work. Eileen A. from GSO shared that they facilitate 12-step work rather than doing it directly, while Kelley C. updated us on the Spanish translation of "Bridging the Gap," now titled "Programa Puente hacia AA." Eileen noted that CNIA does not have separate Treatment or Corrections Chairs, unlike other areas. She shared impressive stats on correctional facilities using tablets for AA literature and mentioned a need for more men in the Corrections Correspondence program. Panels featured discussions on H&I efforts, Corrections, and BTG online interactions. The conference business meeting is still deciding on next year's location, with 28 areas attending this year. I am grateful to have served Area 07

Sharing Session: Ad hoc Committee.
The Fall Assembly is scheduled for October/
November, during which a Trustee will be in
attendance. There are discussions regarding the
duration of the Assembly, specifically whether it will
take place over one day. While some members
support the idea of a Pre-Conference Assembly,
there are differing opinions, with some expressing a
preference against online formats. It may be
premature to propose structural changes at this
time, and further discussion is necessary before
making any decisions.

New Business: Translation Equipment Loan Procedure. Tom A. suggested that loaning our translation equipment be permitted by area officer approval, rather than needing to get approval at ACM. It is standard procedure to approve loaning equipment based on requests as long as there is an officer or appointed chair available to accompany the equipment to the event (for insurance purposes). This discussion was tabled due to time constraints.

#### **Officer Reports:**

Tomorrow at District 22 will be my last Delegate Report. I want to say thank you to all of the Districts that hosted me! I feel greatly appreciated by everyone. I reached my personal goal for the panel. That was to participate in all districts, either at their business meeting or a special event they hosted. In some districts, I participated more than two times. I feel this was a great success. Bringing everyone together and sharing our group's conscience/opinions has fostered Unity and Growth in our Area. My hope is that you all take all this enthusiasm back to your districts and groups! As this panel comes to a close, your service to the Area and those back home in your districts needs to be recognized. You all have done a wonderful job. Thank you for your service.

- 2. Review 2025 Reserve Fund: As of June 30, 2025, the Reserve Fund Assets totaled \$12.481 million, consisting of cash and certificates of deposit. Less the liability for unfulfilled Grapevine subscriptions of \$540K, the Reserve Fund Balance was \$11.941 million. Based on the expense budgets for GSO, Grapevine, and La Viña, the reserve fund balance is equal to 6.42 months of operating expenses. The goal range is coverage of 9 to 12 months.
- 3. Safety continues to be a challenge in our Area and surrounding Areas across the US. Attendance is low with our Spanish members. Fear of immigration and intimidation by politically motivated individuals is real. Know that any disruptive behavior hurts all of us. If your meetings are having problems, please share with this body what/how you're dealing with this. Please don't remain silent. Silence is consent. If one person in the room doesn't feel safe, it is up to the group to take action. Safety Workshops can be an opportunity to help your districts.
- 4. I have read the 2<sup>nd</sup> quarter. The finance report that hopefully, is up on the website. With the decline in attendance at meetings, there is a decline in contributions to GSO. That lets me know that there may be a decline in contributions to the Area and our Districts. This trend may continue for some time, looking at the current economic situation in the USA. I want to caution everyone to move slowly on spending our funds. Do what you can to educate others on sharing rooms, sharing rides, and even participating in our meeting on a hybrid if needed. The concern I share is for the

end of this year, and discussing the spending plan for the next panel with your districts. I am in favor of spending the money on the Trusted Servants from our Area.
