

November Election Assembly Minutes 2025 (Unapproved)

The Election Assembly of the California Northern Interior Area (CRIA) was held in Tracy, CA on Friday, November 14, through Sunday, November 16, 2025.

The meeting was called to order by CRIA Chair Holly J. at noon. Charlie D09 read the Preamble in English, while Alex D54 read the GSR Preamble in Spanish. Brian D37 read the 12 Traditions, and Brenda D34 read the 12 Concepts. Esmeralda D27 read Why We Need a Conference in Spanish. Chris D17 read Why We Need a Conference in English. Michelle D27 read the Anonymity Statement.

Area Chair Holly J. Introduced: Area Officers and Appointed Chair. Newcomers were introduced.

Introductions Past Delegates: Bob Panel 36 (Area 26). Woody R. Panel 50. Paul C. P54, Vikki L. P66, Mike K Panel 68, Jenn D. Panel 72, Tom A. P70

Weekend Overview: Paul C. Panel 54.

District's roll call by Alt-Chair Emily L. Unity of our Area.

The Seventh Tradition collected.

Consideration of Minutes: Destiny D22. Alt-DCM moved to approve, which Chris D34 seconded. The minutes were approved without contest.

New Business: Assembly Structure: I raised a concern about holding a one-day online assembly instead of a regular ACM, noting that we would save \$2,200 with this approach. I wanted to confirm that this amount would indeed be saved.

Assembly in June helps delegates prepare their presentations, but it could conflict with events like the NCCAA conference. Delegates must report to us first before presenting elsewhere, as we've experienced issues in the past.

It is clarified that moving the assembly to June avoids conflicts with graduations in May and helps distribute events more evenly throughout the year. We are open to feedback regarding the timing and format of the assembly, whether we should keep it in May or adjust further. We value everyone's input on this matter.

I advocate for consistently moving the fall assembly to either October or November each year. Historically, we've alternated the dates to accommodate our Pacific Regional trustee and to avoid scheduling conflicts, but even alternating hasn't resolved the issues. Having the assembly on a fixed date would be more efficient.

There's also the question of when the elections will take place—October or November. If we choose November, we could schedule them for the second weekend; however, this might require some attendees to travel far and possibly spend the night. We need to

consider a North-South-Central configuration to minimize travel for everyone.

When discussing the idea of a virtual assembly, I think it's excellent because it enables us to vote on important agenda items that need to be addressed before the September 15th deadline. This format can help streamline our business and keep things timely for the upcoming conference.

Some also noted the low participation rates and our goal to enhance engagement, so we're exploring changes to event days and times.

The motion to conduct a one-year trial in 2027 was accepted.

Spending Plan: Don Treasurer. Area 07, 2026

Spending Plan Summary: We implemented two cost-saving measures regarding mileage: eliminating mileage costs for chairs saved nearly \$3,000, and reduced interpreter mileage to ACMs, saving approximately \$450. The conversation about contributions saw varying support for increasing from \$64,000, with some favoring \$66,000 instead of the proposed \$68,000. Ultimately, the contribution remains at \$68,000. Mixed opinions emerged on attending PRAASA events and 4 special conferences, with no suggestions for reductions but a desire to keep spending below \$15,200, recognizing the events' importance for training. Resistance was noted against lowering the mileage reimbursement to \$0.50 per mile, so instead, it was set back to \$0.70, with a survey planned to explore interest in a \$0.60 rate.

Support is strong for transitioning two ACMs to a virtual format, projected to save \$3,500. We are also gathering feedback on the feasibility of overspending by \$5,000 or \$10,000 on our budget, with preliminary approval for a \$5,000 overspend from many participants. Increased budget allocations for the GSC workshop and unreimbursed district mileage remain at \$1,200 each. Although some members proposed raising the GSO contribution from \$3,600 to \$5,000, we chose not to implement this. Rent assessments for ACMs and storage may yield savings of \$500 to \$1,500, especially with the Pacific Forum in San Diego allowing for potential cost reductions. Other considerations include transitioning assemblies to a two-day format for potential savings of \$2,500 by 2027 and hosting a one-day virtual assembly or Mini-PRAASA to minimize costs. There's also broad support for phasing out unfilled oral translation services and exploring AI for written translation at an estimated cost of \$2,500. It's vital we uphold our principles to maintain our mission. Thank you for your commitment to service.

Assembly Reports:

Winter Assembly 2026, Nick H. (D27): Our committee printed up fliers to hand out at the election assembly. We also picked up the bins from the host committee and will inventory the contents so we know what we need to pick up in preparation for the event. We also plan on attending the wrap-up meeting after the election assembly so we can continue to get some questions answered and learn from the prior host committee's experience. We plan to walk through the facility in the coming weeks to get an idea of how we

will set everything up. Things are going well, and we will also meet again as a committee on 12/7 to go over more planning.

Pre-Conference Assembly Chris L. D19: December 1st, 2025 D19 had a meeting for Pre-Conference Assembly.

Post-Conference Assembly Hector H. D53: We have already reserved the venue for the Post-Conference Assembly, scheduled for May 16-17, 2026, in Merced, CA. The location is the Merced Women's Club, located at 707 W. 22nd St.

Mini PRAASA Marjie E. D17: Members of District 17 have been announcing the Mini-PRAASA in October 2926, encouraging people to get ready to commit to the various volunteer positions. A district committee has not been formally appointed yet, but several members are ready to step up. More will be reported as we get closer! In love and service to AA, Marjie E. D17 DCM

Panel 1:

Step 11. Leo D36: Step 11 of Alcoholics Anonymous (AA) encourages individuals to connect with a Higher Power, which can be understood as God, a spiritual presence, or any source of inspiration. This connection is meant to strengthen their recovery journey. Through regular prayer and meditation, members seek to gain clarity, guidance, and inner peace to support their daily lives.

Tradition 11 Michael D20: A.A. prioritizes personal recovery and confidentiality, allowing members to share their struggles without fear of exposure. This emphasis on anonymity helped me concentrate on my recovery and work through the steps without worrying about how others perceived me. Tradition 11 highlights that supporting one another is more important than individual recognition. When I joined A.A., I felt alone, but I discovered a community dedicated to sobriety and helping each other, which is essential for newcomers.

Concept 11 Martin D56: *While the Trustees have ultimate responsibility for A.A.'s world service administration, they need support from qualified committees, service directors, executives, staff, and consultants. It is essential to carefully consider the makeup of these groups, their members' qualifications, induction processes, rotation systems, and the specific roles of our executives and staff. Additionally, establishing fair financial compensation for these essential workers is crucial.*

Overspending by \$4,167; last year it was \$3,402.52; most were okay with up to \$5,000. 2. We have put contributions at \$66,000: more support for raising to this than \$68,000 instead. 3. There appears to be good support for moving up to 2 ACMs to virtual: savings of \$3,500. 4. The majority support for 8 PRAASA and 4 special conferences this year only – due to travel to Hawaii. -Special conferences: we suggest the 4 chairs attend these. They are Bridge the Gap, Grapevine/La Vina, Archives (only the Alternate Chair attends), National AA Technology Workshop (NAATW). -Total projected costs \$15,200 at \$1,400/person/PRAASA and \$1,000/special conference. -Some suggest all go, as this is how many learn their role and a key part of training, but suggest sending 7 officers and pick 1 chair out of the hat. There are other ways to decide who goes. -That leaves the Archives, Accessibility, Literature, Written Translation (Oral Translation not filled) and AV Tech not attending any conference; it does not seem fair to some. -Note: The Northern California Council of Alcoholic Anonymous (NCCAA) (delegate), Pacific Regional Forum (delegate or other) and Hispanic

Conference (liaison & conference support) are in the spending plan and not part of this discussion. 5. We suggest increasing the GSC contribution from \$3,600 to \$5,000: overwhelming support this to be more self-supporting; it actually costs about \$10,000 and General Service Board/Office picks up the rest. 6. Mileage reimbursement issues: -The majority support keeping mileage reimbursement at \$0.70/mi due to principles and practical issues (e.g., depreciation, maintenance). -Suggest increasing mileage reimbursement for GSC workshops and for mileage unreimbursed other district mileage to \$1,200 and \$1,200. 
GSR Preamble
